- ** In case a shipment is held by U.S. Customs or other government agencies for intensive examination, we will collect the exam service fee \$65/hour with minimum charge of \$65.
- *** Continuous Bond covers \$50,000 liability of customs duties and fees with validity of one full year. Single Transaction Bond (STB) Value = commodity value + duty + taxes per shipment.
